Meet Your Newest Neighbors

Have you met the FY 22 and FY 23 Promise Neighborhoods?

This issue of the newsletter highlights three of the seven FY 22 and FY 23 grantees. Throughout the year, this section will feature all our FY 22 and FY 23 grantees and highlight their activities related to one or more key conditions from <u>A Developmental Pathway for Achieving Promise Neighborhoods Results</u>. Hope Zone Promise Neighborhood and Omega Community Development Corporation (Omega CDC) (FY 22 grantee). Omega CDC is the backbone for the Hope Zone Promise Neighborhood in northwest Dayton, Ohio. Omega CDC engages the Hope Zone community in a variety of ways and places itself in the early implementation (stage 2) for the engagement condition. After completing the first Neighborhood Climate Survey in 2023, Hope Zone staff are digesting and disseminating the updated Scorecard data to their students, families, and neighborhood residents. Hope Zone hosted its Winter Results-Based Accountability Kickoff event, where residents, partners, and Omega CDC staff came together to prepare for this season's Results-Based Accountability TMC certification course. Residents, partners, and staff are completing community organizing training and human-centered design training to build capacity. Omega CDC hired parents and residents as Student Success Navigators and formed a Family Advisory Council to begin managing the support systems and contributing to the solutions. Hope Zone workgroups and the collective impact model lift community voices for quick wins, such as starting a Farmers' Market, door-to-door canvassing, a Hope Zone Business Brunch, and a "Future Self Day." Although Omega CDC is still in the early implementation stage, the grantee is planning for full implementation, when residents will hold more leadership roles and strengthen their own families through solutions. Downtown Hayward Promise Neighborhood (DHPN) (FY 22 grantee). California State University, East Bay leads DHPN, its third Promise Neighborhoods grant in Hayward, California. Although this third grant has many bright spots, the completion of DHPN's planning year also highlighted the pandemic's effects that DHPN families and communities continue to face.



DHPN's **strong partnerships are a key condition** for the first-year launch success. Partners—from organizational leaders to frontline staff—engage in one or more of three networks: the Early Learning Network, the Cradle-to-Career Education Reform Network (K–12 and postsecondary), and the

Neighborhood Health and Empowerment Network. A partner and a backbone staff member co-lead each network to support shared accountability, program implementation, and capacity building. DHPN also works closely with its partners' leadership to make the City of Hayward an Education City, a vision put forth by Mayor Mark Salinas.

As a member of the California Promise Neighborhoods Network, California State University, East Bay also collaborates with Promise Neighborhoods across the state and country to build strong communities of practice and advocate for place-based, cradle-to-career models across the state, resulting in a historic state investment of \$12 million in Promise Neighborhoods. This funding has enabled California State University, East Bay to sustain the South Hayward Promise Neighborhood and collaborate with new state entities such as the California Department of Social Services. Evansville Promise Neighborhood (EPN) (FY 23 grantee). The <u>University of Evansville's Center for Innovation and Change</u> leads EPN in Evansville, Indiana. Since receiving its Promise Neighborhoods grant, EPN has worked tirelessly to establish the key conditions for achieving meaningful results in its footprint. During the October 2023 needs assessment site visit, EPN mentioned one of its goals was to

enhance communications strategies. In January 2024, EPN made a *huge stride in advancing its communications key condition* by publishing its <u>Brand Guidelines</u> package. The package includes EPN's logos, specifications on logo size and logo clear space, examples of logo misuse, brand palette colors, typography, and more! EPN's marketing coordinator, Irais Ibarra, created a comprehensive framework for EPN's brand guidelines. A contractor, Jigsaw Digital Strategies, worked on choosing appropriate logo sizes and clear space, while Irais



focused on identifying key elements such as colors, typography, and imagery. The EPN logo was carefully crafted and underwent 24 variations and 9 color palettes before reaching the final published design. The Brand Guidelines will help EPN, its partners, and the community "create a consistent and professional brand identity that reflects the collective unity" EPN strives for. In the News

Which Promise Neighborhoods made headlines?

Partners for Rural Impact (FY 16/Ext, FY 17, FY 22 grantee): Promise Neighborhood Alum Empowering the Next Generation. A former student who attended Tyner Elementary School during Partners for Rural Impact's (PRI) first Promise Neighborhoods grant is the new Full-Service Community Schools coordinator at Tyner. She looks back on the impact Promise Neighborhoods had on her life growing up in Jackson County and acknowledges how valuable PRI's programs were in helping her navigate the path to college and beyond.

Delta Health Alliance (DHA) (FY 12/Ext, FY 16/Ext, FY 21 grantee): DHA Opens a Sixth Resource and Referral Center. DHA recently cut the ribbon on a sixth Resource and Referral Center in Batesville, Mississippi. Each center provides access to early childhood education learning materials for families, early childhood educators, and the community and offers referrals to families in need of other services such as childcare.

San Diego Promise Neighborhood (FY 18 grantee): SBCS Shines on "60 Minutes" – A Glimpse Into Compassionate Migrant Support. SBCS, the backbone organization of San Diego Promise Neighborhood and graduate Chula Vista Promise Neighborhood, has been extremely busy over the last few months providing crucial support for 600–800 migrants daily on their journey to their final destinations and loved ones. The segment highlights SBCS-led Migrant Welcome Center, which offers fundamental services to migrants processed by Border Patrol. The Center's services help hundreds of individuals avoid being stranded in San Diego and provide the support they need to continue their journey.

Hope Zone Promise Neighborhood (FY 22 grantee): Omega CDC's Collaborative Policy Planning Day With William Julius Wilson Institute and StriveTogether. Omega CDC, the backbone organization for Hope Zone Promise Neighborhood, welcomed key staff from the William Julius Wilson Institute and StriveTogether in



January. The visit explored Omega CDC's policy goal statement, policy priorities from the Northwest Dayton Partnership community vision, and Hope Zone Promise Neighborhood workgroup action plans.

This conference brings together people from across the country who believe all children deserve a safe place to live and opportunities to learn and thrive. Inspired by the theme *Level Up for Success!*, the conference is designed to catalyze collaboration, action, and a renewed commitment to transforming practices, partnerships, and systems.

A Review of the Domains of Well-Being for Young People

The authors of this <u>research report</u> describe eight domains of youth well-being and considerations for their measurement. The youth field—or people working with and doing research related to young people, such as policymakers, funders, researchers, and practitioners—needs information as it considers investments and interventions to support youth development. The report summarizes traditional and emergent approaches to measurement of youth well-being and notable gaps in each area. It also includes key themes relevant to all domains and highlights the need to include young people in developing well-being concepts and indicators.

Data Deep Dive


What can we learn from the FY 12 cohort?

Promise Neighborhoods grantees collect a wide range of data to help tell the story of their communities, monitor progress toward goals, and spark inquiry into solutions. Each quarter, Promise TTA will take a deep dive into these data and highlight a story within the numbers.

The FY 12 cohort has collected a full decade of Government Performance and Results Act (GPRA) indicator data. Let's explore how high school graduation rates have changed over the 10-year lifetime of these grants using this dataset. Examine trends in each grantee's data in the figure and consider how contextual factors like the COVID-19 pandemic might affect GPRA indicators. How can awareness of these impacts help newer grantees interpret their data and continually improve their solutions?

Funding Opportunities

Where can Promise Neighborhoods seek funding to sustain and grow their impact?

The National Science Foundation's Smart and Connected Communities

This grant supports use-inspired research that addresses communities' social, economic, and environmental challenges. Projects must work with community stakeholders on pilots that integrate intelligent technologies with the natural and built environments. Applications are due April 1, 2024.

The Max and Victoria Dreyfus Foundation

The Max and Victoria Dreyfus Foundation has issued a request for proposals for projects designed to improve economic mobility by focusing on the needs of communities. The Foundation will consider requests to support museums; cultural and performing arts programs; schools and hospitals; educational, skills-training, and other programs; environmental and wildlife protection activities; and other community-based organizations and programs. Applications are accepted on a rolling basis.



Bank of America Charitable Foundation Philanthropic Strategy

The Bank of America Charitable Foundation has issued a request for proposals for projects designed to improve economic mobility by focusing on the needs of communities. Grant funding will support affordable housing, neighborhood revitalization, and small business resiliency. Applications will be accepted from May 27, 2024, to June 21, 2024.

Securing Funding for the Collective Impact Backbone Role: Lessons From the Field

Siegel Family Endowment and Walton Family Foundation's Learning Landscapes Challenge

The Learning Landscapes Challenge will help changemakers integrate social, digital, and physical infrastructure to bridge the learning of today with the learning of tomorrow. The challenge is a \$2.2 million competition to design and build future-ready K-12 education environments. Siegel Family Endowment and the Walton Family Foundation invite changemakers to propose infrastructure solutions that deliver and connect digital, in-school, and community-based learning experiences. Phase 1 submission deadline is May 14, 2024.

<u>Urban Institute's Student Upward Mobility Initiative</u>

The Urban Institute (Urban) is seeking proposals that develop new or improved PK–12 measures or that connect measures of PK–12 skills and competencies to economic mobility, while ensuring we think about individuals in context. Urban expects to fund \$3 million in research grants, ranging from \$50,000 to \$500,000, through this year's competition. The RFP opened March 11, 2024, and mandatory LOIs due April 30. Invited applicants will be able to submit full proposals between mid-May and June 28, 2024.
